### ***Research interests***

Research in the legal field at the Department of Political Science of the University of Genoa has traditionally developed towards the comparative analysis of the religious phenomenon, of religious and political institutions in the Mediterranean countries, of the relationship between the Italian State and religious confessions present in the territory. In this sense, Prof. Daniela Tarantino, in addition to the purely canonistic research and focused in particular on the confessional seal, is currently engaged in a line of research concerning the study of the role of religion within the migratory phenomenon, in particular in the phase of departure and arrival of migratory flows, in order to outline models of relationship between the law of the state and the law of religions, trying to identify hypotheses of resolution that can start from confessional norms and interreligious

dialogue as the foundation of a multicultural society. In this sense, the examination of the role played by organizations characterized religiously that deal with the reception of migrants and interreligious dialogue, is connected to the examination of canonical legislation, the papal magisterium and intercultural pastoral care following the Second Vatican Council, which made of the promotion of the dialogic approach of religions, respecting every cultural identity, a hermeneutical criterion for the reading of the 'signs of the times' and of the human experience in its genesis and in its religious manifestation. Through the affiliation to some important scientific associations including the Association of professors of ecclesiastical and confessional disciplines in Italian universities (ADEC) and the Consociatio Internationalis Studio Iuris Canonici Promovendo, participation in the Scientific Committee of the International Innocent III Chair and the International Journal 'Vergentis', and the period of study as a visiting researcher at the Faculty of Law of the University of Coimbra, the teacher maintains scientific collaborations to promote the development of national and European research projects.

From the 2016/2017 academic year in the courses entrusted to the University of Genoa (Institutions of Canon Law and Ecclesiastical Institutions and Religious Institutions in the Mediterranean Countries), she organizes and coordinates the cycle of accredited seminars 'Walking together: canonistic paths in a multidisciplinary perspective'.

As part of her research interests, she has participated as a speaker at numerous national and international conferences such as for example: With the report entitled 'Confession and sacramental seal in the Fourth Lateran Council: from normative to doctrinal reflection', she participated in the International Congress 'Innocent III and his time.
